You are invited to audition students for the 6<sup>th</sup> annual SDMEA Middle School All State Orchestra! We are especially looking forward to this year's event given our cancellation last year due to Covid-19. Next year's event will include the SDSTA J. Laiten Weed Honors Orchestra and the 5<sup>th</sup> annual String Symposium. The String Symposium will include professional development for credit and a music reading session.

#### **Eligibility Requirements**

Students in grades 6-8 who are currently enrolled in a South Dakota public or private school orchestra program are eligible to audition. Audition recordings must be submitted by the orchestra teacher or the student's private lesson instructor. If no orchestra teacher is at the school, the band teacher may submit the recordings. The orchestra/band director or private lesson instructor MUST be a current member of SDMEA. Selected participants are required to be in attendance for ALL rehearsals of MSASO. Please check your calendars to avoid conflicts. In most cases, no alternates will be placed for those students that are selected and choose not to attend the event.

#### **Audition Requirements**

Auditions will be submitted online beginning October 15, 2021. We are asking for video auditions submitted through an unlisted link on YouTube into a Google Form. Audition materials and instructions for uploading and submitting the video auditions are available by going to the SDMEA.net web link at the top of this page.

Audition deadline is <u>November 15, 2021</u>. Any auditions submitted to the Google Form after 11:59 PM CDT on November 15, 2021 will not be accepted. This allows for a prompt adjudication, with notification to the director's email by December 11, 2021, and on the SDMEA website soon after.

There is a \$9 audition fee (per audition).

- Payment accepted only by check made out to SDMEA; do not send cash.
- Please submit only one check per school.
- Mail check to Laura Cooper (Address below).
- Checks need to be postmarked by November 23, 2021.

There will be an additional registration fee of \$9 per student selected to the orchestra, and that registration fee will be due <u>February 1, 2022</u>. **Submitted auditions that do not meet the eligibility and/or audition requirements will not be adjudicated.**

### **Chad Hutchinson**

#### Conductor, 2022 SDMEA Middle School All State Orchestra

Chad Hutchinson is an Assistant Professor and the Director of Orchestral Activities at Eastern Michigan University. In addition to conducting the Symphony Orchestra, he teaches courses in conducting, music education and supervises student teachers in the field. Dr. Hutchinson recently completed two years at the University of Wisconsin-Madison where he was the Interim Director of Orchestras, led University Opera productions and taught undergraduate and graduate conducting courses. In two seasons, he led the ensemble in works of Caroline Shaw, William Grant Still, Adam Schoenberg, Christopher Theofanidis and Mason Bates, collaborated on a residency with Augusta Read Thomas with the Symphony Orchestra in addition to conducting works by Beethoven, Brahms, Tchaikovsky and Mahler. With the University Opera program, Hutchinson led performances of La Boheme, Into the Woods, L'incoronazione di Poppea and Kurt Weill: A Cabaret.

Prior to his time in Madison, Dr. Hutchinson was the Assistant Conductor of the South Dakota Symphony Orchestra and Music Director of the South Dakota Symphony Youth Orchestras. During his tenure, he led the SDSO in numerous pops concerts including artists Ben Folds, Michael Cavanaugh and Steve Lippia, implemented the orchestra's inaugural season of Carnegie Hall's Link Up program in a partnership with the Sioux Falls Public School

District, conducted Family Concerts and led the annual "Christmas on the Prairie" concert in Hoven, SD. Working with students ages 8-18 and conducting three of the four ensembles within the organization, he helped the SDSYO grow to the largest enrollment in the program's history, gaining over 75 students in two seasons. Committed to new music, each SDSYO ensemble featured a living composer on every concert in the 2016-2017 season. In addition, the Youth Orchestra performed works by and had residencies with John Luther Adams and Theodore Wiprud while also being one of only three youth ensembles in the country to premiere "Dreamtime Ancestors" by Christopher Theofanidis.

As comfortable in the pit as on the stage, Dr. Hutchinson was recently named the 2017-2018 winner of The American Prize in Opera Conducting for his performance of *Suor Angelica* with University Opera Theatre at the University of Minnesota. He has recently led productions of *La Bohème, Le Nozze di Figaro, Susannah, Suor Angelica, Lady in the Dark, A Kurt Weill Revue* and *The Mikado* with University Opera at the University of Wisconsin-Madison, University Opera Theatre at the University of Minnesota, and Morningside College. *Into the Woods* and *L'incoronazione di Poppea* with University Opera at UW-Madison both were awarded 1st place in the National Opera Association's 2018-2019 Production Competition. Other recent honors have included being awarded 2<sup>nd</sup> place in The American Prize in Orchestral Conducting for his work with the University Symphony Orchestra at The University of Minnesota, 2<sup>nd</sup> place in The American Prize's Vytautas Marijosius Memorial Award in Orchestral Programming for his work with the South Dakota Symphony Youth Orchestra as well as being named a finalist for the 2017 Pierre Monteux Prize in conducting.

With a long-standing commitment to education, Hutchinson taught orchestra in the public schools for nine years in Williamsville, NY and Sioux Falls, SD with both programs more than doubling in size during his tenure. In South Dakota, the Roosevelt High School Chamber Orchestra was selected to play for the South Dakota Music Educators Convention and in New York, he created a biennial "Night at the Opera" concert where his ensembles performed portions of *Don Giovanni* and *Tosca*. He later taught collegiately at Iowa's Northwestern College and was the coordinator and music director of the Siouxland Youth Orchestras in Sioux City, Iowa. He has served as a guest conductor for numerous orchestras and festivals throughout the Midwest, Montana and New York and has been on the conducting faculty of the International Music Camp for several years. As a conducting fellow, he has been selected to participate in conducting workshops at the Juilliard School, Eastman School of Music, the New England Conservatory of Music, the Richmond Symphony and the Bohuslav Martinu Philharmonic Orchestra.

An lowa native, Dr. Hutchinson holds conducting degrees from the University of Minnesota and Bowling Green State University and a bachelor's degree in music education from Morningside College. Away from the university, he enjoys spending time with his wife and two daughters, training for triathlons as well as rooting for the lowa Hawkeyes and Kansas City Royals.




#### AUDITION RECORDING REQUIREMENTS

- 1) Record three separate videos per student: One video for the <u>Major Scale</u>, one video for the <u>Melodic Minor Scale</u>, and one video for the <u>Etude</u>.
- 2) You are allowed to record as many different "tries" as you want, but settle on one video for each section.
- 3) Make sure both hands are clearly visible in the recording.
- 4) There should be no talking during the videos.
- 5) The videos should be one continuous take. Do not edit multiple tries together.

#### HOW TO UPLOAD AUDITIONS TO YOUTUBE


- 1) Register for and/or sign in to your Google Account if you have not already done so.
- 2) Go to www.YouTube.com
- 3) Click the create video and more button at the top of the page to access the upload page.



- 4) Select upload video.
- 5) Drag and drop your videos onto the upload page.
- 6) Title each video with the <u>student's initials</u>, their instrument, and the piece they are playing.
  - For example, if my cello student's name is Yo-Yo Ma and he is playing the Major Scale, please title the video "YM Cello Major Scale"
  - Do not include any other information in the title or description (such as school or grade)
- 7) For privacy and security, you must mark the video "Unlisted."
- 8) Click "Done."
- 9) Copy the web link that appears to share in the "MSASO Audition Google Form."





# Violin Audition Etude - Year B





## **Viola Audition Scales**








